



Brownrice Internet – Electricity & Renewables Summary (Last 12 Months)

Demand & On-site Generation

- **Total electricity used (Brownrice only):** 245.98 MWh/yr
- **On-site solar (Brownrice array):** 81.10 MWh/yr (Source: Brownrice PV production logs)

Grid Sourcing (via Kit Carson Electric → Guzman Energy)

- **Grid electricity consumed:** 164.88 MWh/yr
- **Renewable share of Guzman/KCEC supply:** ~60% of KCEC's retail load served by renewable resources under the contract extension (Guzman Energy, 2023).
- **Renewable energy from grid:** 98.93 MWh/yr (calculated @60%).

REC Purchase & Net 100% Green Power

- **Renewable Energy Certificates (RECs):** Brownrice purchased **66 MWh** of RECs from Terrapass (Terrapass). **Terrapass certificate/receipt:** XZSTXLD3-tpus-1182583 (dated 08/22/2025).
- These RECs credibly offset the remaining non-renewable grid energy (**65.95 MWh**), bringing our **net electricity use to 100% renewable**. The purchase slightly exceeds the gap by ~0.05 MWh, which is retired in our favor.

Summary

Brownrice Internet is now **fully green powered (100% renewable)** on a net annual basis. This reflects on-site solar generation, renewable electricity from Guzman/KCEC, and retirement of 66 MWh of RECs from Terrapass to cover the remaining non-renewable grid energy.

*Total renewable slightly exceeds annual load due to rounding and REC oversupply (~0.05 MWh).
